

ORDINANCE NO. 3462

TITLE: AN ORDINANCE OF THE CITY OF ALBANY ADOPTING A GENERAL PENALTY AND REPEALING ALL OTHER PENALTY PROVISIONS AND DECLARING AN EMERGENCY.

THE PEOPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:

Section 1: PENALTY FOR VIOLATION.

Any person violating any of the provisions or failing to comply with any of the mandatory requirements of the ordinances of the City of Albany shall be guilty of a misdemeanor. Any person convicted of a misdemeanor under the ordinances of the City of Albany shall be punished by a fine of not more than FIVE HUNDRED DOLLARS (\$500.00), or by imprisonment not to exceed one year, or by both such fine and imprisonment. Each such person shall be guilty of a separate offense for each and every day during any portion of which any violation of any provision of the ordinances of the City of Albany is committed, continued, or permitted by any such person, and he shall be punished accordingly.
