

ORDINANCE 5331

AN ORDINANCE AMENDING ORDINANCE NO. 5289, SEGREGATING THE LIEN OF SUMMERHILL JOINT VENTURE FOR SAID PROPERTY BEING DESCRIBED AS TAX LOT #300, OF PARCEL 10-04W-25; AND DECLARING AN EMERGENCY.


Section 2: The City Recorder is hereby directed to enter a statement of the assessments as above provided in the docket of the City liens and give notice thereof as provided by law.

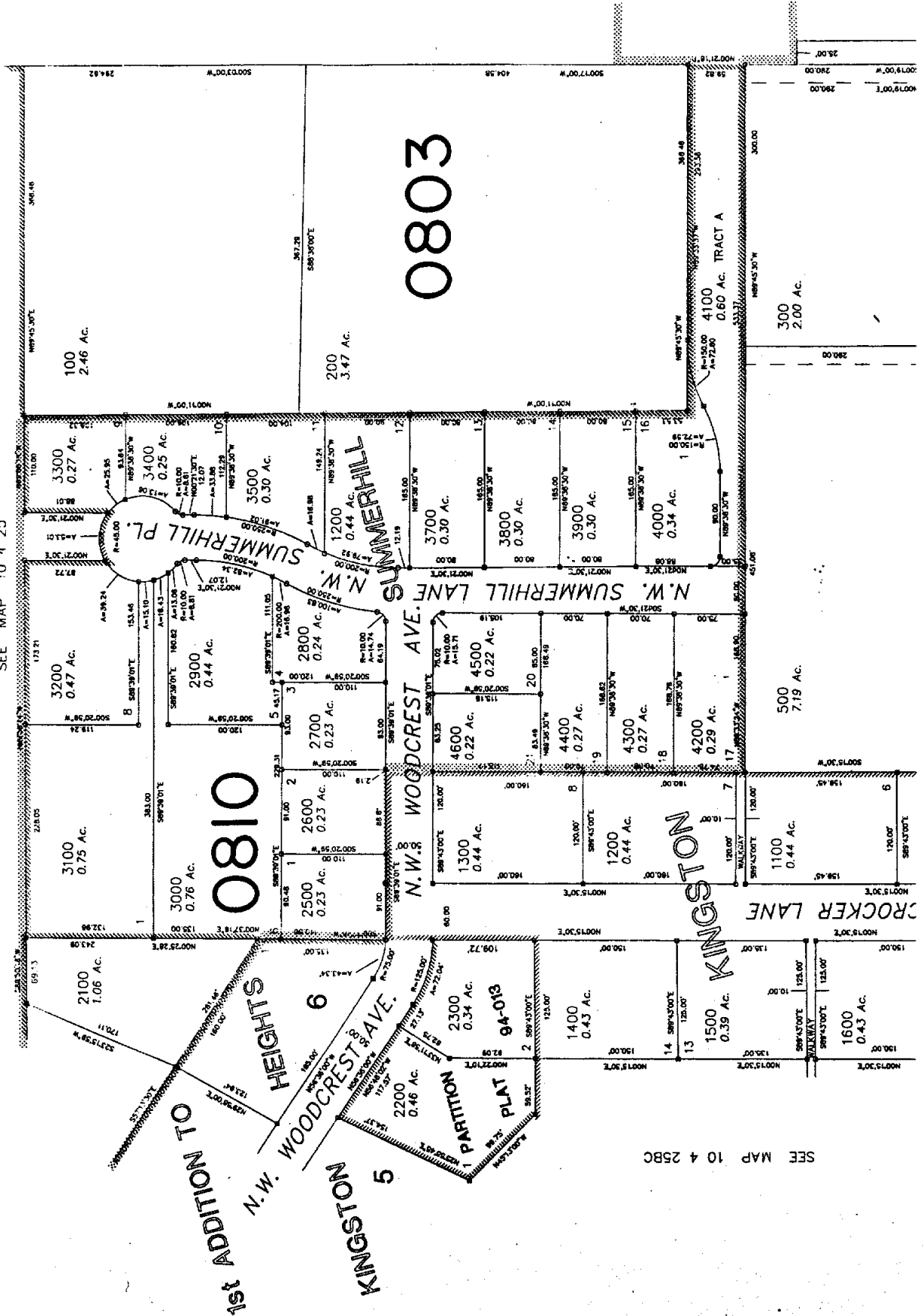
