

TO WITHDRAW PROPERTIES ANNEXED TO THE CITY OF ALBANY FROM RURAL
FIRE PROTECTION DISTRICT OF WHICH THEY ARE NOW A PART

WHEREAS, §222.524 ORS provides the procedure for withdrawal of a part of a rural fire protection district when said part of the district is annexed to a city and there have been numerous annexations to the City of Albany of property which were, at the time of annexation and still are, a part of the rural fire protection district, and

WHEREAS, it is necessary to hold a public hearing concerning the withdrawal of these annexed territories from the rural fire protection district of which they are a part, now, therefore,

BE IT HEREBY RESOLVED by the Council of the City of Albany that 7:15 p.m., May 10, 1961, shall be the time and the Council Chambers in the City Hall, City of Albany, Linn County, Oregon shall be the place for hearing objections, if any there shall be, to the withdrawal of all properties annexed to the City of Albany from December 14, 1955, through March 7, 1961, and at such hearing, objections shall be heard as to why said property should not be withdrawn from the respective rural fire protection districts of which they are now a part,

BE IT FURTHER RESOLVED that notice of the time, place and purpose of the public hearing to be held on the 10th day of May, 1961, be published in a newspaper of general circulation in the City of Albany at least two (2) successive times being one each week for two successive weeks prior to the date of the hearing and that the City Recorder shall post notice of said hearing and the purpose thereof in four (4) public places in the city for a like period.

BE IT FURTHER RESOLVED that the annexations which shall be the subject matter of this hearing are referred to as Exhibit "A" by Ordinance number, date of passage and Ordinance titled which Exhibit "A" is attached hereto and by this reference made a part of this Resolution.
