RESOLUTION NO. 1933

A RESOLUTION ESTABLISHING RESIDENTIAL AND COMMERCIAL RATES TO BE CHARGED BY FRANCHISEE FOR THE COLLECTION OF REFUSE IN THE CITY OF ALBANY, OREGON.

NOW, THEREFORE, BE IT RESOLVED by the Albany City Council that the following rates shall be established as those rates for the purpose of refuse collection:

Residential & Commercial Can Service Rates. Rates to be charged by a franchisee for the collection of refuse in the city shall not exceed those established by the following schedule:

First 32-gallon (or less) can (collected once weekly)	\$3.60
Second can	2.10
Each additional can	2.10
Minimum charge for extra service not	1.80
Curb pickup only (to be effective as a discount for a period of six (6) months from the effective date of	2 20
this resolution)	3.30

The charge for occasional additional pickup of refuse removed from yards or buildings shall be a reasonable charge for each pickup and such additional charge as the size and nature of the particular articles to be hauled will justify.

<u>Commercial Container Service Rates</u>. Rates to be charged by a franchisee for the collection of refuse and rubbish in the city shall not exceed those established by the following schedule:

BE IT FURTHER RESOLVED that no consideration will be given to an additional rate increase at any time prior to twenty-four months from January 1, 1978; and if the franchisee requests a rate increase after the twenty-four months, he will make an application to the City at least six months prior to the expiration of the twenty-four month period.

BE IT FURTHER RESOLVED that the curb pickup fee as established will be reviewed at the end of the 6-month period to decide whether or not it will be continue to be a charge.
