A RESOLUTION OF THE CITY OF ALBANY, OREGON, AUTHORIZING APPLICATION FOR DELEGATION OF ELECTRICAL PROGRAM

WHEREAS, Linn and Benton County presently are responsible for electrical inspection of all construction within the City of Albany; and

WHEREAS, the City of Albany presently has contracted with Benton County to assume many of those inspection obligations of North Albany; and

WHEREAS, the City of Albany has the necessary expertise to assume responsibility for all electrical inspections City-wide; and

WHEREAS, consolidation of all construction inspection duties of City construction will promote efficiency, reduce governmental red tape and improve customer service; and

WHEREAS, State law allows the transfer of electrical inspection duties from the County to the City;

NOW, THEREFORE, be it resolved as follows:

Section 1. The City Council hereby authorizes the application by City staff on behalf of the City for the delegation of the electrical program; and

Section 2. The City represents that if the application is granted, the City and all persons under it will comply with and be bound by OAR Chapter 918, Divisions 300, 302, 303 and 304.

Section 3. If the application is granted, the fees to be charged for electrical inspection and plan review shall be as set forth in Exhibit "A," attached hereto.
