Meagher, hereinafter referred to as Grantor, hereby dedicate to the City of Albany, a Municipal Corporation, hereinafter called "City" for right-of-way purposes, portions of that real property situated in Linn County, Oregon, conveyed to Grantors by deed recorded in MF Volume 639, Page 236, Linn County Deed Records, and being more particularly described as follows:

A piece of land in Section 8 of Township 11 South in Range 3 West of Willamette Meridian, City of Albany, Linn County, Oregon as described in the attached Exhibit A, as shown on the attached map labeled Exhibit B and the attached vicinity map labeled Exhibit C.

The Grantor covenants that they are lawfully seized and possessed of the real property above described and that they have a good and lawful right to convey it or any part thereof and that they will forever warrant and defend the same against all persons who may lawfully claim the same.

#### **EXHIBIT "A"**

(Easement description)

A tract of land lying in the Southwest 1/4 of Section 08, Township 11 South, Range 3 West, Willamette Meridian, Linn County, Oregon, said tract being a portion of that property described in MF Volume 639, Page 236, Linn County Deed Records, said tract being more particularly described as follows:

Beginning at the intersection of the north right-of-way line of Queen Avenue with the west right-of-way line of Oak Street in the City of Albany, Oregon; thence South 89°50'20" West, on said north right-of-way line, a distance of 46.43 feet; thence leaving said right-of-way line, North 80°01'29" East 31.95 feet; thence North 38°32'23" East 12.33 feet to a point on the west right-of-way line of Oak Street; thence South 25°49'39" East, on said west right-of-way line, a distance of 16.72 feet to the Point of Beginning.

The bearings and right-of-way determination used in this description were based upon County Survey Number 25294, as filed in the office of the Linn County Surveyor.






