



RESOLUTION NO. 7286

A RESOLUTION OF THE ALBANY CITY COUNCIL, ACTING AS THE LOCAL CONTRACT REVIEW BOARD, WAIVING COMPETITIVE BIDDING AND AWARDING A SOLE-SOURCE CONTRACT TO AMERICAN TRAFFIC SOLUTIONS INC., DBA VERRA MOBILITY FOR PROVIDING A PHOTO ENFORCEMENT PROGRAM AND EQUIPMENT; AND AUTHORIZING THE POLICE CHIEF TO NEGOTIATE, AWARD AND EXECUTE A CONTRACT WITH AMERICAN TRAFFIC SOLUTIONS, INC., DBA VERRA MOBILITY TO PROCURE A PHOTO ENFORCEMENT PROGRAM AND EQUIPMENT

WHEREAS, Oregon Revised Statutes 279B.075, and Oregon Administrative Rules (OAR 137-047-0275) allow the city council, acting as the local contract review board, to award a contract for goods and services without competition by Sole-source Procurement if it is determined that the goods or services are available from only one source; and

WHEREAS, such authorization must be based on written findings submitted by the department seeking the exception that describe the circumstances to support the use of the Sole-source Procurement as defined in ORS 279B.075; and

WHEREAS, the current photo enforcement contract with RedFlex Traffic Systems, Inc., now American Traffic Solutions, Inc., DBA Verra Mobility, expires in 2024; and

WHEREAS, a new contract would allow the City to expand the program to a total of four different approaches throughout the city with the capability of red light and speed enforcement; and

WHEREAS, American Traffic Solutions, Inc., DBA Verra Mobility is the sole provider of the Albany Police Department photo enforcement program and equipment; and

WHEREAS, for the efficient utilization of the existing photo enforcement software and equipment it is in the City's best interest to expand the enforcement program to include both photo red light and photo speed enforcement at four approaches with the sole source provider, American Traffic Solutions, Inc., DBA Verra Mobility.

NOW, THEREFORE, BE IT RESOLVED THAT THE ALBANY CITY COUNCIL, ACTING AS THE LOCAL CONTRACT REVIEW BOARD:


Adopts the following findings:

1. In order to efficiently utilize existing equipment and services, American Traffic Solutions, Inc., DBA Verra Mobility is the sole provider of the goods and services required to expand Albany Police Department's use of photo red light enforcement and add photo speed enforcement capabilities at four approaches in the city for five years with an option for extensions.
2. Continued utilization and expansion of American Traffic Solutions, Inc., DBA Verra Mobility's products and services for photo red light and photo speed enforcement by the Albany Police Department is cost effective, aligns with the City's strategic plan, and is in the City's best interest.

SECTION 2. Notwithstanding the provisions of Albany Municipal Code Section 2.66.060, the police chief is authorized and directed to use a Sole-source Procurement method to procure the photo red light and photo speed enforcement program.


SECTION 3. The police chief is hereby directed to negotiate, award, and execute a sole-source contract with American Traffic Solutions, Inc., DBA Verra Mobility for photo red light and photo speed enforcement equipment for a term of five years, with the option of extensions, after the City has given public notice for seven days of its intent to award a contract, per OAR 137-047-0275 and ORS 279B.075.
