Call to Order	The Chair, Councilor Hal Brauner, called the meeting to order.	Meeting called to order at 3:02 pm.
2. Agenda Review		There were no changes to the agenda.

4. Minutes of May 29, 2018 meeting		Consensus by the Loop Board to approve the May 29, 2018 meeting minutes as written.
5. Service Analysis Update	Phil Warnock advised that everything is in place contractually in order to move forward with the Service Analysis. The COG has provided invoices to partners for their contributions to the total project cost. The TAC had projected a total cost of \$60,000, and the consultant cost came in at \$719 higher. It was agreed to move forward with the higher cost, knowing that the project could come in at a shorter cost if the survey is done in-house and if needed, additional funds may be added from each of the MPO budgets.	Consensus by the Board to approve the Public Involvement Plan as presented.

Tarah Campi noted that staff developed draft Public Involvement recommendations that have been reviewed, and edited by the TAC. Board members received a final draft for review and consideration of approval. Recommendations include some steps that can be evergreen and pulled out as best practices for the Loop going forward. However, the content is specific to the Service Analysis Plan process. Most of the work will be handled by COG staff in partnership with Albany Transit staff in regards to receiving public comments and website updates. It outlines the presentations to the representative TAC and Board, a public comment period, concluding with a public hearing, as well as accepting comments by email and in writing.

Warnock noted that there are considerations on the interaction between the Board and the TAC. The TAC will hold a Project Kick-off meeting on Friday, September 7th that the Board may attend, or the Board may have a separate meeting for a presentation by the consultant. With the project being on a tight time schedule, staff recommendation is for Board members to attend the scheduled TAC meeting and actively participate in that conversation.

Bruce Clemetson noted that he will be sending a staff to the September 7th meeting. Hal Brauner noted that the joint meeting is sufficient and the Loop Board does not need a separate briefing by the consultant.

Multimodal Network Connectivity Grant:

Nick Meltzer reported that COG staff responded to a grant opportunity to look at multimodal network connectivity, through the Federal Highway Administration. This is a joint AAMPO and

	CAMPO effort. The pilot project will measure multimodal network connectivity, specifically looking at connections throughout the region. Chair Brauner advised that he sees a direct connection between the Multimodal Network Connectivity grant and the Loop Service Analysis. He hopes to see close coordination between the two projects.

Update on Loop SDP Project Activities and Deliverables

This is an update for the Linn-Benton Loop Board on the first Deliverables from our Service Development Plan project.

SDL Activities to Date

- The Service Development Plan officially kicked off on Friday, September 7, 2018, with a joint meeting of the TAC and Loop Board members, led by the project consultants, Nelson Nygaard.
- At the kick-off meeting, a project overview was provided; the project Scope of Work
 was reviewed; the planning context for the project summarized; the scope of some of
 the initial deliverable reports was discussed; needs and opportunities were reviewed
 with the group; and finally next steps and action items were covered.

Project Meeting Schedule

 A key project management team meets by phone on a weekly basis. This consists of the consultants, and representatives from the COG; the Loop operator; and the TAC Chair. Additionally, regular formal TAC meetings for the duration of the project have been devoted to project document reviews and exercises. The dates that were established so far for these are:

Tuesday, October 2nd, 2:30 – 4:30 pm

Tuesday, November 6th, 2:30 – 4:30 pm

Tuesday, December 18th, Strategies Workshop 12:30 – 4:30 pm

Tuesday January 15 or 22, 2:30 - 4:30 pm

Tuesday March 5, 2:30 - 4:30 pm

A copy of the current project schedule Gantt chart prepared by Nelson Nygaard is attached.

 The 12/18/18 Strategies Workshop will be a key meeting, so please request the Loop Board members to hold that date in their calendars. The location will be the Downtown Corvallis Fire Station, upstairs conference room (Large City Council chamber), from 12:30 – 4:30pm. A catered lunch will be provided.

On-Board Loop Ridership Survey

- With assistance from OSU, professor Ann Scheerer's upper division Sustainability Assessment 304 volunteered to assist the Loop project with our on-board survey effort.
- The TAC had already drafted a survey document, which the consultants assisted us with refining into a professional one-page tool. A "primer " for the students conducting

the survey was also developed. A copy of each is attached.

- On October 11, TAC members Lee Lazaro and Sarah Bronstein briefed Professor Scheerer's class. Approximately 600 printed surveys and supplies were distributed. A total of 34 students, divided into 17 teams of two, were allocated between six days of morning, mid-day, and afternoon Loop routes.
- Surveys were conducted between October 12 and October 20, 2018, with 16 out of 17 teams delivering survey results. Results are still being tabulated and analyzed, but at last count we have at least 239 completed on-board surveys.
- The students were then grouped into larger teams which are each preparing policy briefs, analyzing their key findings and recommendations. These should hopefully be available to the TAC by the end of November.

Project Deliverables - Technical Memo's 1, 2, and 3

- To date, three project deliverables have been drafted by the consultants and reviewed by the TAC. Technical Memo's #2 and #3 are combined into one document, while Tech Memo #1 is a standalone document. These documents were reviewed with the TAC at our November 6 meeting, and edits and input was provided back to Nelson Nygaard.
- Technical Memorandum No.1 Existing Conditions and Needs Assessment. This report summarized the current environment in which the Loop operates, including all the partner transit systems in both counties. It provides a listing of all the existing planning documents which have been completed or are underway which may influence the Loop study; analyzes demographics of the Loop operating environment; and provides a detailed description of the Loop service itself. The report ends with a summary of the already-known transportation needs of the Loop service population.
- Technical Service Memorandum No. 2 Evaluation Framework. This report outlines the proposed evaluation process for projects to be proposed in the service development plan. A three-tiered approach that ranks projects into short-term and medium term time frames, and by cost levels, is proposed. A table of different evaluation criteria is laid out, including cost, schedule, frequency, service expansion, service quality, and access (meeting HB2017 low-income criteria).
- **Technical Service Memorandum No. 3 Funding Scan.** This report provides a very detailed listing of all the potential funding sources for public transit projects, operations, and capital, in a table format. Current operating revenues and operating budget for the Loop are also provided.
- Updated copies of these three reports, which include the edits and feedback provided to the consultants from TAC members at our 11/6 meeting, should be coming to the Board directly from the consultants at your 11/27 meeting.



What is your job?

- To distribute passenger surveys as riders board the bus.
- To assist any rider with a survey if they ask.

Distributing and Collecting Surveys

- Distribute a pen and survey to each passenger who boards the bus.
- Collect completed surveys and pens when passengers are finished with the survey.
- At the end of your shift, try to bundle all completed surveys together.
- Fill in the gray box on the bottom right of the first page of each survey form. This will help with survey analysis.

- Loop service to Corvallis, LBCC and Downtown Albany, including on Saturday
- Express Service between Downtown Corvallis and LBCC only

SURVEYING TIPS

- Briefly introduce yourself to the driver, so that they know who you are and what you are doing. Be mindful not to distract them, though.
- Wait until a passenger has found a seat or standing location before approaching them.
- When you hand them a survey, provide a brief explanation of the survey. For example, "Hello, the Linn-Benton Loop is surveying passengers to improve transit service. Here is a survey".
- Be polite and respectful; if a passenger does not want to take the survey move on to the next person.
- Politely assist any rider with the survey if they ask.

What do we expect of you?

- Show up early to your starting location for your bus trip. The bus will not wait for you.
- Professional behavior. As a surveyor, you are representing OCWCOG, ATS, and OSU.
- You may not eat or drink on the bus. Bring any snacks with you in a bag and only eat or drink during breaks when you are off the bus.

Remember:

- We are not here to cut service.
- When on the vehicle, the driver is your boss. Follow any instructions the driver tells you.
- Even though you are working as an OSU student, on behalf of OCWCOG, the public may likely see you as a representative of Linn-Benton Loop. Please make sure all of your actions reflect well on the all of these agencies.
- Don't be afraid to ask questions.
