Approval of June 27, 2023, minutes

Motion: Commissioner Allyson Dean moved to approve the June 27, 2023, minutes. Commissioner Greg Soriano seconded the motion, which passed 7-0.

Land acknowledgement recommendation to the City Council

6:38 p.m.

The group agreed that they would like to recommend a land acknowledgement statement to be read at City meetings or printed on the meeting agendas. Kolkow will put a committee together to work on a statement. He will bring a prepared statement to the group at next month's meeting. If the group approves the statement, they will present it to the City Council in the fall.

Kolkow would like to form a committee to create an equity, diversity, and inclusion survey. Commissioner Miriam Cummins, Commissioner Robyn Davis, and Dean all expressed an interest in being on that committee.

HRC meeting time

Cummins and Commissioner Elyn Fisher said that they did not receive the email asking them which meeting time they preferred. Lyddane will resend the email. When she receives their responses, she will email the group with the new meeting time.

HRC project updates

6:54 p.m.

a. Coffee with a Commissioner:

Dean requested that this project be put on hold until after the group's work session so that the members who are representing the group at the event are clear on the HRC's goals and what the commission would like to convey. The group agreed.

b. Community Walk:

Soriano reported that he walked the 1.5-mile route and found it to be safe and that there is adequate parking at the facility. Fisher will invite local law enforcement to the event. Soriano has invited the Linn Benton National Association for the Advancement of Colored People. The walk will be held at 10:00 a.m. on September 9, 2023. The group agreed to title the event Walk & Roll. Staff will forward a flyer with additional details to the group that they can send out to their contacts. Lyddane confirmed that the Public Works department gave permission for the group to use the facility on September 9 for the event. The department did caution that the trail is comprised of natural surfaces and some portions of it might be harder for wheelchairs to maneuver. Kolkow will reach out to the event booth vendors in his list of contacts.

Kolkow informed the group that there was communication from the Anti-Defamation League to the City regarding comments made at the May 24, 2023, council meeting. They are planning on attending an upcoming City Council meeting. Kolkow encouraged the group to track upcoming council agendas to discover when this will take place.

Dean asked Lyddane whether Festival Latino could be conducted in conjunction with the Parks & Recreation's Summer Sounds events. She requested that the department share with the community on how people can apply to be a Summer Sounds performer. Lyddane will investigate the feasibility and report back to the group.

Cummins stated that she would like to advocate for more representation for the Latinx community. She has received feedback from the Latinx community that they would like to have a cultural community experience with music and dance called a bailar.
