Call to Order

Chair Chuck Kratch called the meeting to order at 3:30 p.m.

Approval of August 17, 2023, Minutes

3:31 p.m.

Debbie Origer made a motion to approve the August 17, 2023, minutes as presented. Garry Barnes seconded the motion, and it passed unanimously.

Staff Updates 3:32 p.m.

Transportation Manager Robb Romeo reports Wes Jones has stepped down from the AAC. He then proceeded to report they have been keeping an eye on the mole and nutria problem at the airport and haven't seen any nutria lately. They also had their yearly meeting with the Federal Aviation Administration to go over the five-year Capital Investment Plan. The FAA declined runway projects to save money for bigger airports for the next few years, but there will be money available for some of the smaller items on the airport project list attached in the agenda packet. Romeo also gave the AAC a "heads up" that there is a sewer line being placed that will run under the freeway and lead to the south gate of the airport, which will mean some of the roads will be closed around the airport for a bit.

FBO Updates 3:43 p.m.

Tony Hann mentions there are some pilots in Albany wanting to fund and build a grass runway on the east side of the current runway. This idea has been presented in the past and rejected due to lack of space, but the laws have relaxed a bit, so they are wanting to revisit the idea. He also presented the desire to purchase a solar/battery powered back up system to run the fuel pump for \$3800 that could potentially only need to be recharged once a month so it would also be helpful if there were a long-term power outage as well. Lastly, Hann reports Phillips 66 came out for their annual inspection, and it went very well.

Business from the Commission

3:54 p.m.

Gar Burroughs suggested the commission start off the year with a talk about the budget and where the AAC stands financially. In response, Romeo gave a brief rundown of what the budget looks like at this time, and suggested they find ways in the future to create new revenue. Burroughs also recommended the city give advanced warning to the people who lease the hangars when their renewal is getting close so there

are no surprises. Garry Barnes asked Romeo what kind of event he would suggest to help create revenue and the participants discussed different ideas. Kratch asked Hann to invite the Stark family from Twin Oaks Airpark to attend the next AAC meeting virtually and talk about their fundraisers that have been a huge success.

Debbie Origer informed the commission that the 1929 Hangar Project is now going to be a part of the Albany Regional Museum through a fiscal sponsorship where they will pay the museum a percentage (to be determined) to take in donations to fund the project. They have formed a steering committee of 9 people meeting for the first time on Dec 7 to get organized and create a mission statement so they can move forward and start raising funds to refurbish the hangar and hold events there in the future. Origer informed the committee she will be stepping down from her current position in the AAC and will continue to attend monthly as a community member, as she feels it is a conflict of interest with her new role as Chair on the 1920 Hangar Project committee.
